THE FALKIRK COUNCIL (EDWARD, AVENUE, STENHOUSEMUIR) (TEMPORARY PROHIBITION OF TRAFFIC) (NO.TTRO/2192) ORDER 2022

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily prohibit traffic on Edward Avenue, Stenhousemuir Larbert from 07:30 hours on 06/07/22 until 17:00 hours on 17/07/22, which two separate phases. The prohibition is to allow carriageway surfacing work to be carried out safely.

2. This Order temporarily closes Edward Avenue, Stenhousemuir:
 - Phase 1 - from its junction with Inverary Drive to its junction Blenheim Place.
 - Phase 2 - from its junction with Blenheim Place to its junction with Muirhead Road.
3. The alternative route is:
 - Phase 1 - Antonshill Roundabout (A88) – New Carron Road (B902) – King Street (B905), Muirhead Road/Margaret Terrace, Edward Avenue and vice versa.
 - Phase 2 – Edward Avenue, Antonshill Roundabout (A88) – New Carron Road (B902) – King Street (B905), Muirhead Road/Margaret Terrace and vice versa.

THE FALKIRK COUNCIL (EDWARD, AVENUE, STENHOUSEMUIR) (TEMPORARY PROHIBITION OF TRAFFIC) (NO.TTRO/2192) ORDER 2022

Falkirk Council, in exercise of the powers conferred by Section 14(1) and (4) as read with Section 2(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, being satisfied that the traffic on the lengths of Road specified in the Schedule to this Order should be restricted or prohibited as hereinafter provided because works are being or are proposed to be executed on or near the said lengths, hereby make the following Order:-

Citation, commencement and cessation

- (1) This Order may be cited as "The Falkirk Council (Edward Avenue, Stenhousemuir) (Temporary Prohibition of Traffic) (TTRO/2192) Order 2022 and shall come into force from 0730 hours on 06/07/22 until 1700 hours on 17/07/22 or until completion of the works, whichever is sooner.

Interpretation

- (2) The Interpretation Act 1978 shall apply for the interpretation, of this Order as it applies for the interpretation of an Act of Parliament.

Temporary Prohibition on Use of a Road

- (3) Subject to article 4, no person shall use, or permit the use of, any vehicle on the length of Road and during the period(s) specified in the schedule when a prohibition is identified as applying to a part or parts of that length of road by means of one or more of the traffic signs prescribed in the Traffic Signs Regulations and General Directions 2016.

Exemption for Emergency and Works Vehicles

- (4) Article 3 does not apply to a vehicle being used in an emergency for Scottish Fire Rescue Service; Maritime and Coastguard Agency; Scottish Ambulance Service; or Police Scotland purposes; or a vehicle whilst being used for carrying out the works.

07:30 hours on 06/07/2022 to 17:00 hours on 17/07/2022

Alternative Route:

- Phase 1 - Antonshill Roundabout (A88) – New Carron Road (B902) – King Street (B905), Muirhead Road/Margaret Terrace, Edward Avenue and vice versa.
- Phase 2 – Edward Avenue, Antonshill Roundabout (A88) – New Carron Road (B902) – King Street (B905), Muirhead Road/Margaret Terrace and vice versa.
