THE FALKIRK COUNCIL (A905, AIRTH) (TEMPORARY PROHIBITION OF TRAFFIC) (TTRO/2219) ORDER 2022

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily prohibit vehicles on A905 Airth from 08.00 hours on 19/09/22 until 17.00 hours on 02/10/22 the prohibition is to allow for Surfacing works to be undertaken.

2. This Order temporarily closes A905 Airth, from its junction with B9124 in a south easterly direction for approximately 204 metres or thereby.

The alternative route is A905, A905 Graham Terrace, A905 Main Street, A905 from Pow Burn Bridge to Main Street, A905 from Bowtrees North Roundabout to Pow Burn Bridge, A905 Bowtrees North Roundabout, A905 from Bowtrees South Roundabout to Bowtrees North Roundabout, A905 Bowtrees South Roundabout, A905 from South Bellsdyke Roundabout to Bowtrees South Roundabout, A905 South Bellsdyke Roundabout, A88 Bellsdyke Road, A88 Antonshill Roundabout, A88 Bellsdyke Road, A88 Tryst Roundabout, A88 Bellsdyke Road, A88 Inches Roundabout, A88 Bellsdyke Road, A88 Bellsdyke Roundabout, A88 Bellsdyke Road, A9 North Broomage Roundabout, A9 Stirling Road, A9 Glenbervie Roundabout, A9 from Glenbervie Roundabout to Council Boundary, A9 Main Street, A9 Falkirk Road, A91, A91 Greenyards Roundabout, A91 Bannockburn, A91 Skeoch Roundabout, A905 Stirling Road, A905 Main Street, A905 Kersie Road, A905 from Graham Terrace Airth to Council Boundary and vice versa.

Falkirk Council, in exercise of the powers conferred by Section 14(1) and (4) as read with Section 2(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, being satisfied that traffic on the lengths of Road specified in the Schedule to this Order should be restricted or prohibited as hereinafter provided because works are being or are proposed to be executed on or near the said lengths, hereby make the following Order:-

Citation, commencement and cessation

- (1) This Order may be cited as "The Falkirk Council (A905 Airth) (Temporary Prohibition of Traffic) (TTRO/2219) Order 2022" and shall come into force from 08.00 hours on 19/09/22 until 17.00 hours on 02/10/22 or until completion of the works, whichever is sooner.

Interpretation

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.


Temporary Prohibition on Use of a Road

- (3) Subject to article 4, no person shall use, or permit the use of, any vehicle on the length of Road and during the period(s) specified in the schedule when a prohibition is identified as applying to a part or parts of that length of road by means of one or more of the traffic signs prescribed in the Traffic Signs Regulations and General Directions 2016.

Exemption for Emergency and Works Vehicles

- (4) Article 3 does not apply to a vehicle being used in an emergency for Scottish Fire Rescue Service; Maritime and Coastguard Agency; Scottish Ambulance Service; or Police Scotland purposes; or a vehicle whilst being used for carrying out the works.
