THE FALKIRK COUNCIL (VARIOUS ROADS, FALKIRK) (TEMPORARY PROHIBITION OF WAITING) (TTRO/2270) ORDER 2023

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984 to temporarily prohibit waiting in Various Roads, Falkirk from 07.00 hours on 03/04/23 to 16.00 hours on 14/08/23. The prohibition is to allow for gas mains replacement works to be undertaken.

2. This order prohibits waiting on both sides of Tamfourhill Road from its junction with Lime Road in an easterly direction for approximately 570 metres or thereby.
3. This order prohibits waiting on both sides of Lime Road from its junction with Tamfourhill Road in a southerly direction for approximately 20 metres or thereby.
4. This order prohibits waiting on both sides of Kilbrennan Drive from its junction with Lime Road in an Easterly direction for approximately 310 metres or thereby.
5. This order prohibits waiting both sides of Cumbrae Drive from its junction with Kilbrennan Drive in an easterly direction for approximately 235 metres or thereby.
6. This order prohibits waiting on both Sides of Kintyre Place from its junction with Cumbrae Drive in an easterly direction for approximately 105 metres or thereby.
7. The alternative route is: Not applicable.

THE FALKIRK COUNCIL (VARIOUS ROADS, FALKIRK) (TEMPORARY PROHIBITION OF WAITING)(TTRO/2270) ORDER 2023

Falkirk Council, in exercise of the powers conferred by Section 14(1) and (4) as read with Section 2(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, being satisfied that waiting on the lengths of Road specified in the Schedule to this Order should be restricted or prohibited as hereinafter provided because works are being or are proposed to be executed on or near the said lengths, hereby make the following Order:-

Citation, commencement and cessation

- (1) This Order may be cited as "The Falkirk Council (Various Roads, Falkirk) (Temporary Prohibition of Waiting)(TTRO/2270) Order 2023" and shall come into force from 07.00 hours on 03/04/23 to 16.00 hours on 14/08/23 or until completion of the works, whichever is sooner.

Interpretation

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Temporary Prohibition on Use of a Road

- (3) Subject to article 4, no person shall wait, or permit to wait, any vehicle on the length of Road and during the period(s) specified in the schedule when a prohibition is identified as applying to a part or parts of that length of road by means of one or more of the traffic signs prescribed in the Traffic Signs Regulations and General Directions 2016.

Exemption for Emergency and Works Vehicles

- (4) (4) Article 3 does not apply to a vehicle being used in an emergency for Scottish Fire Rescue Service; Maritime and Coastguard Agency; Scottish Ambulance Service; or Police Scotland purposes; or a vehicle whilst being used for carrying out the works.

Both sides of Lime Road from its junction with Tamfourhill Road in a southerly direction for approximately 20 metres or thereby.
Both sides of Kilbrennan Drive from its junction with Lime Road in an Easterly direction for approximately 310 metres or thereby.
Both sides of Cumbrae Drive from its junction with Kilbrennan Drive in an easterly direction for approximately 235 metres or thereby.
Both Sides of Kintyre Place from its junction with Cumbrae Drive in an easterly direction for approximately 105 metres or thereby.

Period of Prohibition:

From 07.00 hours on 03/04/23 to 16.00 hours on 14/08/23
