THE FALKIRK COUNCIL (A904 OUTSIDE HELIX PARK, FALKIRK) (TEMPORARY FOOTWAY CLOSURE) (NO.TTRO/1888) ORDER 2023

The Council has made the above named Order under section 14(1) of the Road Traffic Regulation Act 1984, that the footway on the north side of the A904 outside the Helix Park will be temporarily closed from 06.00 hours on 16/10/23 until 18.00 hours on 16/04/25, Falkirk Council being satisfied that the execution of the works requires this duration for completion. The footway closure is necessary for public safety reasons during road improvement works.

2. This Order temporarily closes the footway on the north side of the A904 outside the Helix Park, Falkirk.

Falkirk Council, in exercise of the powers conferred by Section 14(1) and (4) as read with Section 2(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, being satisfied that the traffic on the lengths of Footway specified in the Schedule to this Order should be restricted or prohibited as hereinafter provided because works are being or are proposed to be executed on or near the said lengths, hereby make the following Order:-

Citation, commencement and cessation

- (1) This Order may be cited as "The Falkirk Council (A904 outside Helix Park, Falkirk) (TTRO/1888) Order 2023" and shall come into force from 06.00 hours on 16/10/23 until 18.00 hours on 16/04/25, Falkirk Council being satisfied that the execution of the works requires this duration for completion.

Interpretation

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Temporary Prohibition on Use of a Road

- (3) Subject to article 4, no person shall use, or permit the use of, the length(s) of footway and during the period(s) specified in the schedule when a prohibition is identified as applying to a part or parts of that length of road by means of one or more of the traffic signs prescribed in the Traffic Signs Regulations and General Directions 2016.

Exemption for Emergency and to Undertake the Works

- (4) Article 3 does not apply in an emergency for Scottish Fire Rescue Service; Maritime and Coastguard Agency; Scottish Ambulance Service; or Police Scotland purposes; or for the purposes of carrying out the works.
