THE FALKIRK COUNCIL (ON-STREET PARKING SPACES FOR DISABLED PERSONS REVOCATION) (VARIOUS STREETS NO 12) ORDER 2023

Falkirk Council in exercise of their powers under the Road Traffic Regulation Act 1984, as amended (hereinafter referred to as “the 1984 Act”) and of other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. This Order may be cited as “Falkirk Council (On-Street Parking Spaces for Disabled Persons Revocation)(Various Streets No 12) Order 2023” and shall come into operation on the 9 day of May, Two Thousand and Twenty Four.
2. This Order hereby revokes The Falkirk Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Decriminalised Parking Enforcement and Consolidation) Order 2018 insofar as it relates to the disabled persons parking bays described in the schedule as indicated on plans listed in the schedule.
3. The effect of this Order will be to remove the designated sections of road described in the Schedule hereto as a parking space for disabled persons vehicles.

Location of Parking Space for Disabled Persons Vehicles to be Removed

Deanfield Road, Bo'ness
TRO/23/035
Revocation no. 816

On the west side of Deanfield Road from the projected south building line of 8 Deanfield Road in a northerly direction for a distance of 6.6 metres or thereby.

Crownest Loan, Stenhousemuir

Revocation no. 817

On the east side of Crownest Loan from the projected north boundary line of 15 Crownest Loan in a southerly direction for a distance of 6.6 metres or thereby.

Windsor Avenue, Falkirk

On the south side of Windsor Avenue from the projected west boundary line of 21 Windsor Road in an easterly direction for a distance of 6.6 metres or thereby.

Kilsyth Road, Banknock

On the south side of Kilsyth Road in the layby from the projected west boundary line of 206 Kilsyth Road in an easterly direction for a distance of 6.6 metres or thereby.
