THE MIDLOTHIAN COUNCIL (PARKING PLACES FOR DISABLED MOTORISTS)
(VARIATION NO 1) ORDER 2021

The Midlothian Council in exercise of the powers conferred on them by Sections 1(1), 2(1) to 2(3), 4(2), 32 and 35 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Roads (Scotland) Act 1984 and modified by The Road Traffic (Permitted Parking Area and Special Parking Area) (Midlothian Council) Designation Order 2018 (SSI 2018/60) (which Act as so amended and modified is in this Order referred to as "the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:

1. This Order may be cited as "The Midlothian Council (Parking Places for Disabled Motorists) (Variation No 1) Order 2021" and shall come into operation on the Fifteenth day of March Two thousand and twenty-one.
2. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the 1984 Act or by or under any other enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Midlothian Council (Parking Places for Disabled Motorists) Order 2011 shall have effect subject to the variations, insertions and amendments specified in the Schedule to this Order.
