

**THE MORAY COUNCIL  
(AMENDMENT TO THE GRAMPIAN REGIONAL COUNCIL (OFF STREET CAR  
PARKS) ORDER 1989: (PROPOSED CHANGES TO EXISTING CAR PARK  
CHARGES, ELGIN): (PROPOSED PAY AND DISPLAY WAITING RESTRICTIONS  
– RAILWAY STATION CAR PARK, COOPER PARK AND NORTH COLLEGE  
STREET WEST, ELGIN) ORDER 2018**

The Moray Council in exercise of its powers conferred upon it in terms of Section 35 of the Road Traffic Regulation Act, 1984, as amended, and all other enabling powers and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:-

1. This Order may be cited as “The Moray Council (Amendment to the Grampian Regional Council (Off Street Car Parks) Order 1989: (Proposed Changes to Existing Car Park Charges, Elgin): (Proposed Pay and Display Waiting Restrictions – Railway Station Car Park, Cooper Park and North College Street West, Elgin) Order 2018 and will come into operation on 11<sup>th</sup> May 2018.
2. This Order shall amend certain provisions of The Grampian Regional Council (Off Street Car Parks) Order 1989, as amended.
3. Each direct reference to a car park by the naming of it in the Schedule to this Order and each direct reference therein to period of charge, vehicle type and level of charge relevant to that car park, shall hereby be taken to replace, respectively, each direct reference to that car park in the schedule to The Grampian Regional Council (Off Street Car Parks) Order 1989, as amended, and each direct reference therein to the period of charge, vehicle type and level of charge relevant to that car park. Otherwise, direct reference to car parks named in the Schedule hereto, and direct reference therein to period of charge, vehicle type and level of charge relevant to those car parks, where the car parks in question were not named in the schedule to The Grampian Regional Council (Off Street Car Parks) Order 1989, as amended, shall hereby be taken to have been added to the latter schedule.
4. This Order shall add the following definitions to Article 2 of the Grampian Regional Council (Off Street Car Parks) Order 1989, as amended;  
  
“cashless payment” means payment either online, via mobile phone or by means of a credit or debit card (chip and pin) by insertion into the ticket parking meter;  
  
“handheld device” means a device used by a parking supervisor to verify the time of day and period of time for which payment has been made; “
5. This Order shall revoke Article 4(3) and Article 4(4) of The Grampian Regional Council (Off Street Car Parks) Order 1989, as amended and replace with the following;

- “4. (3) Save as provided in Article 4(2) above, the initial charge shall be payable on leaving the vehicle in the off-street car park either by:
- (a) purchasing a pay and display ticket by the insertion into the ticket issuing machine of a combination of coins of the denominations indicated on that ticket parking meter such that their total value is not less than the appropriate initial charge, as detailed in the schedule hereto; or
  - (b) making a cashless payment where the total value is not less than the appropriate initial charge, as detailed in the schedule hereto.
4. (4) If a ticket issued by the ticket parking meter is obtained for the vehicle by payment of the initial charge, the ticket shall be exhibited on the vehicle in accordance with the provisions of this Article. No other ticket issued by a parking meter shall be exhibited on the vehicle. Where a cashless payment has been made, the electronic record of that payment shall be deemed to be equivalent to the display of a ticket obtained under the provisions of this Article”.
6. This Order shall revoke Article 9 of The Grampian Regional Council (Off Street Car Parks) Order 1989, as amended and replace with the following;
9. (1) Payment of the initial charge for a vehicle left in a car park shall be indicated by (i) a ticket parking meter relating to the car park in which the vehicle has been left, of a numbered ticket, and by the exhibition of that ticket on the vehicle, or (ii) the electronic record of a cashless payment on the handheld device indicating that the initial charge has been made, in accordance with the provisions of this order.
- (2) The expiry of the period for which the initial charge has been paid shall be indicated when there is exhibited on the vehicle a ticket, issued by a ticket parking meter relating to the car park in which the vehicle is left, indicating a day and time, and when the time shown on the clock on the said ticket parking meter is later than the time shown on the ticket, or (ii) a cashless payment has been made and the date and time indicated on the handheld device is later than the time shown on the electronic record of that transaction.
