THE MORAY COUNCIL (SECTION OF U123E MOSS OF BARMUCKITY ROAD – STOPPING UP) ORDER 2018

The Moray Council, as planning authority for Moray, in exercise of the powers conferred on them by Section 207 of the Town and Country Planning (Scotland) Act 1997, hereby make the following Order authorising the stopping-up of a section of the U123E Moss of Barmuckity Road, Elgin.

1. This Order may be cited as “The Moray Council (Section of U123E Moss of Barmuckity Road - Stopping Up) Order 2018” and will come into operation on 21 May 2019.
2. The Interpretation Act 1978 shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
3. Where, immediately before the date this Order comes into force, there is under, in, on, over, along or across the length of road described in the Schedule, any apparatus of a statutory undertaker, any rights of the statutory undertaker in respect of such apparatus shall be preserved.
4. Subject to the provisions of this Order The Moray Council, as planning authority, in order to form a road layout and access for a Business Park at BP1 Barmuckity, Elgin Moray compliant with planning permission granted to the developer by The Moray Council on 14 July 2011, hereby authorise the stopping-up of a section of the U123E Moss of Barmuckity Road, Elgin as described in the Schedule hereto and as shown outlined and hatched red on the plan signed and executed with reference to this Order and marked “Plan referred to in The Moray Council (Section of U123E Moss of Barmuckity Road - Stopping Up) Order 2018” on the Twenty-fifth day of July, Two Thousand and Eighteen.
