

**North Ayrshire Council
(West Kilbride Yuletide Event)
(Temporary Closure) Order 2016**

The North Ayrshire Council, in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984, as amended, hereby make the following Order.

1. This Order may be cited as "The North Ayrshire Council (West Kilbride Yuletide Event) (Temporary Closure) Order 2016" and shall come into operation as specified in the Schedule to this Order.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of emergency and associated event vehicles) on the lengths of roads specified in Schedule to this Order.
3. No person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time in any of the lengths of roads specified in Schedule to this Order.

STATEMENT OF REASONS

It is considered necessary to make the above Order due to the Yuletide Festival, which is proposed to be executed on or near the public road.

EXTENT AND DURATION

Ritchie Street at Alton Street and Arthur Street junction to end of Main Street and Main Street to the end of Glen Road and are to be closed to vehicular traffic and no waiting and no loading under the terms of Section 16A of the Road Traffic Regulation Act 1984 on the following dates and time detailed below.

PROHIBITION OF DRIVING

1. Glen Road – 15:00hrs to 22:00hrs on Friday 2 December 2016.
2. Main Street and Ritchie Street – 17:00hrs to 22:00hrs on Friday 2 December 2016.

ALTERNATIVE ROUTES

Diversion routes will be signposted and will be in place for the duration of the event(s).

EFFECT

The Order will apply to the specified roads at the above times as indicated by appropriate traffic signs, cones or under the instruction of a police officer in uniform and the effect will be to impose temporary restrictions on use.
