(Waiting and loading restriction) Order 2016**

The North Ayrshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991 and of all other enabling powers, hereby makes the following Order :-

**PROHIBITION OF WAITING AND LOADING**

1. Sanderson Avenue from no. 31 to its junction with McKinlay Crescent (both sides) and McKinlay Crescent between no 81 and 97 (both sides), Irvine, from **08:00 hours on Monday 21<sup>st</sup> November until 16:00 hours on Friday 16<sup>th</sup> December 2016**, or until the works are completed whichever is the earlier.
2. No person shall allow any motor vehicle to wait or load (with the exception of vehicles engaged on maintenance works) on Sanderson Avenue and McKinlay Crescent, Irvine, by reason of works to be executed on or near the public road.

### **STATEMENT OF REASONS**

It is considered necessary to make the above Order to facilitate BT upgrade works being carried out under traffic control, which are to be executed on or near the public road.

### **EXTENT AND DURATION**

Sanderson Avenue and McKinlay Crescent, Irvine is to be restricted in relation to Waiting/Loading under the terms of Section 14 (1) of the Road Traffic Regulations Act, 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act, 1991.

Sanderson Avenue from no. 31 to its junction with McKinlay Crescent (both sides) and McKinlay Crescent between no 81 and 97 (both sides), Irvine, from 08:00 hours on Monday 21<sup>st</sup> November until 16:00 hours on Friday 16<sup>th</sup> December 2016, or until the works are completed whichever is the earlier.

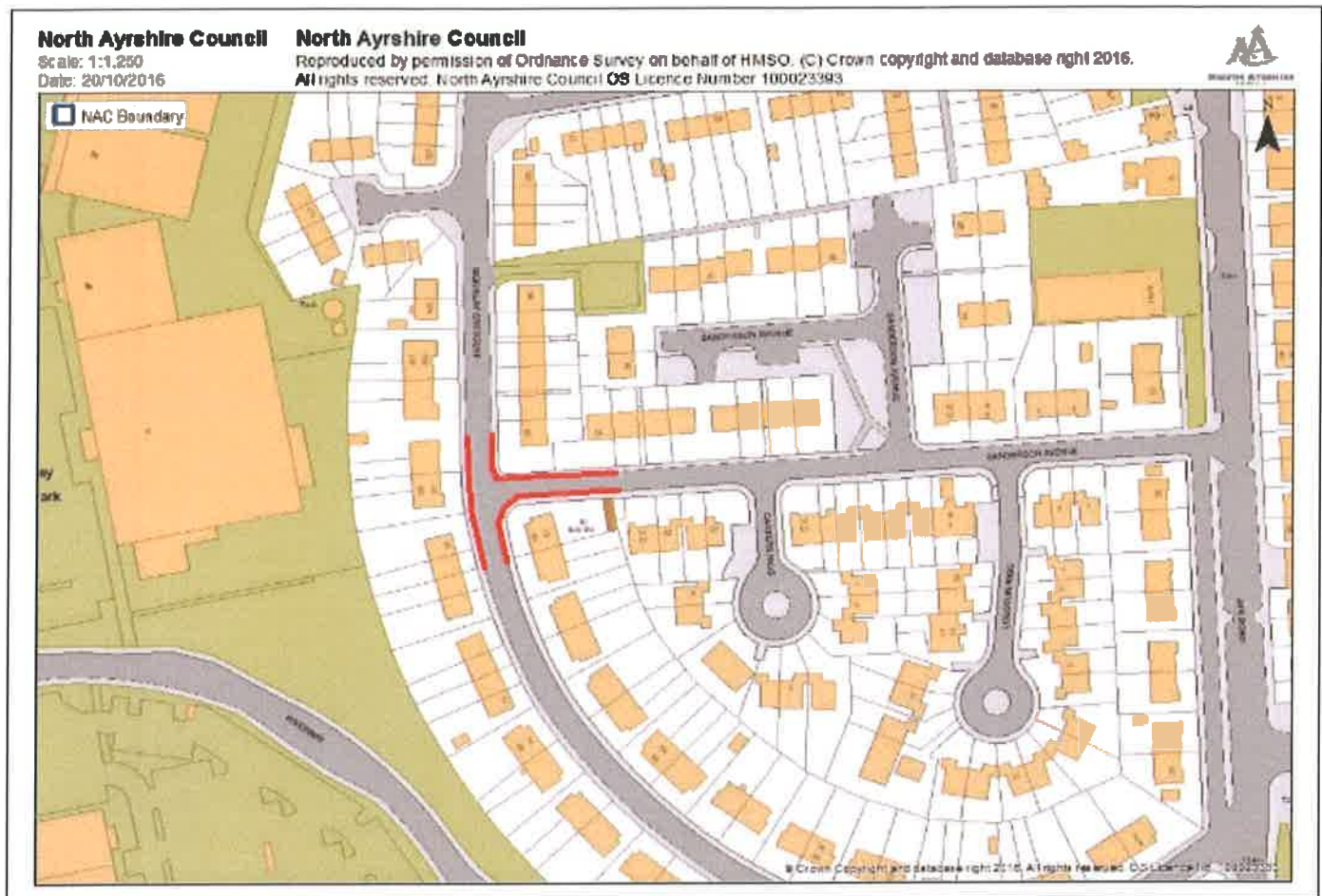
### **EFFECT**
