(Temporary Closure) Order 2016

The North Ayrshire Council, in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984, as amended, hereby make the following Order.

1. This Order may be cited as “The North Ayrshire Council (Beith Christmas Lights and Laughter Night) (Temporary Closure) Order 2016” and shall come into operation as specified in the Schedule to this Order.
2. No person shall drive or cause or permit to be driven any motor vehicle (with the exception of emergency and associated event vehicles) on the lengths of roads specified in Schedule to this Order.
3. No person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait at any time in any of the lengths of roads specified in Schedule to this Order.

STATEMENT OF REASONS

It is considered necessary to make the above Order due to the Christmas Events, which are proposed to be executed on or near the public road.

EXTENT AND DURATION

Main Street, King's Road, Mitchell Street and Wilson Street, are to be closed to vehicular traffic under the terms of Section 16 of the Road Traffic Regulation Act 1984 on the following dates and time detailed below.

PROHIBITION OF DRIVING

Main Street, King's Road and Wilson Street - 1700hrs to 2200hrs on Friday 2 December 2016.

Mitchell Street - 0800hrs to 2200hrs on Friday 2 December 2016.

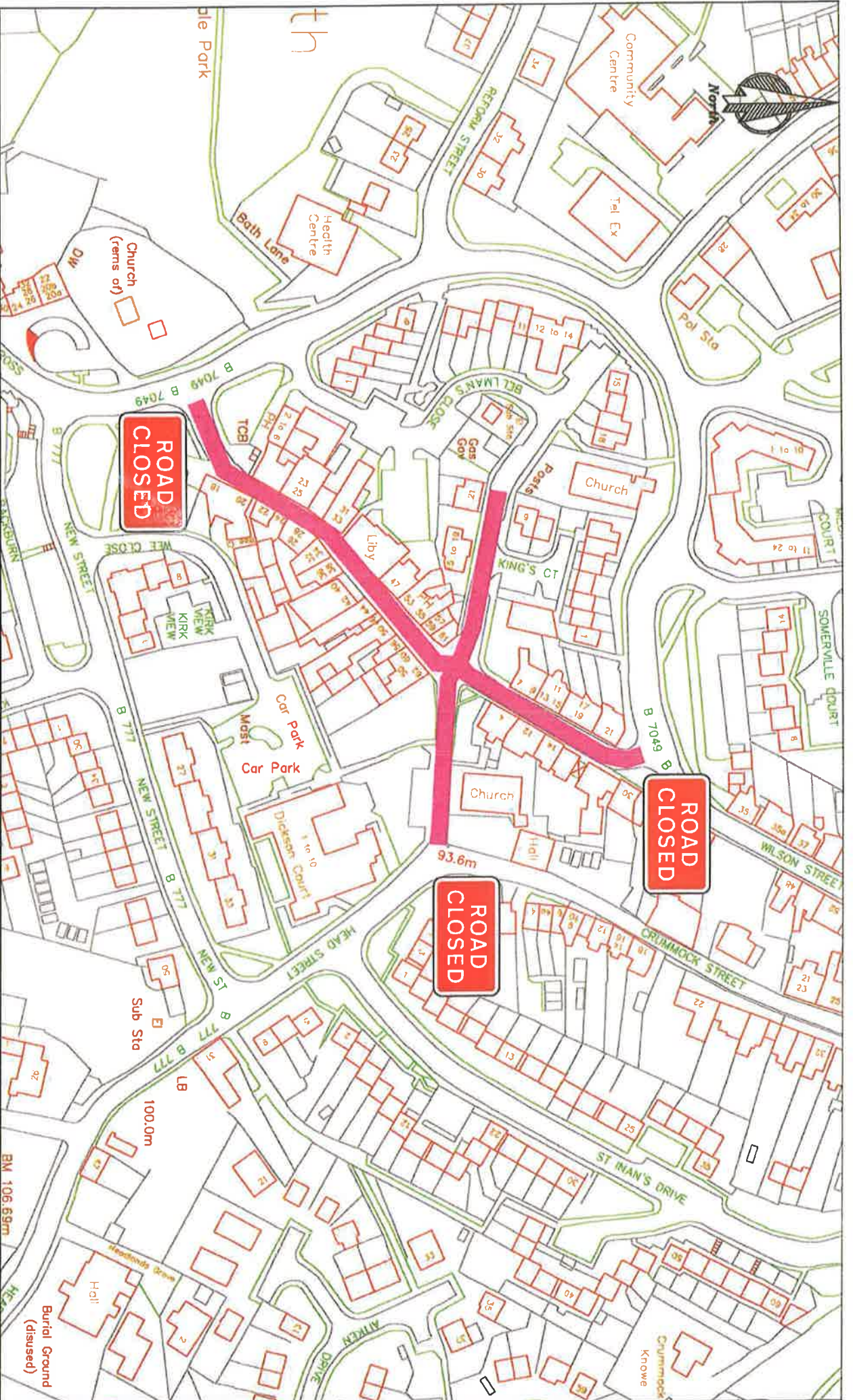
ALTERNATIVE ROUTES
