**PERTH AND KINROSS COUNCIL (RESTRICTED ROADS)  
(VARIATION) (NO 32) ORDER 2019  
(06/19)**

The Perth and Kinross Council in exercise of the powers conferred on them by Sections 84(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1 This Order may be cited as the "Perth and Kinross Council (Restricted Roads) (Variation) (No 32) Order 2019" and shall come into operation on the Twenty-third day of January Two thousand and nineteen.
- 2 The Perth and Kinross Council (Restricted Roads) Order 1998 is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the Schedule hereto.

1. At **PART I** of the **SCHEDULE**, after 20 **CRIEFF** insert the following:-

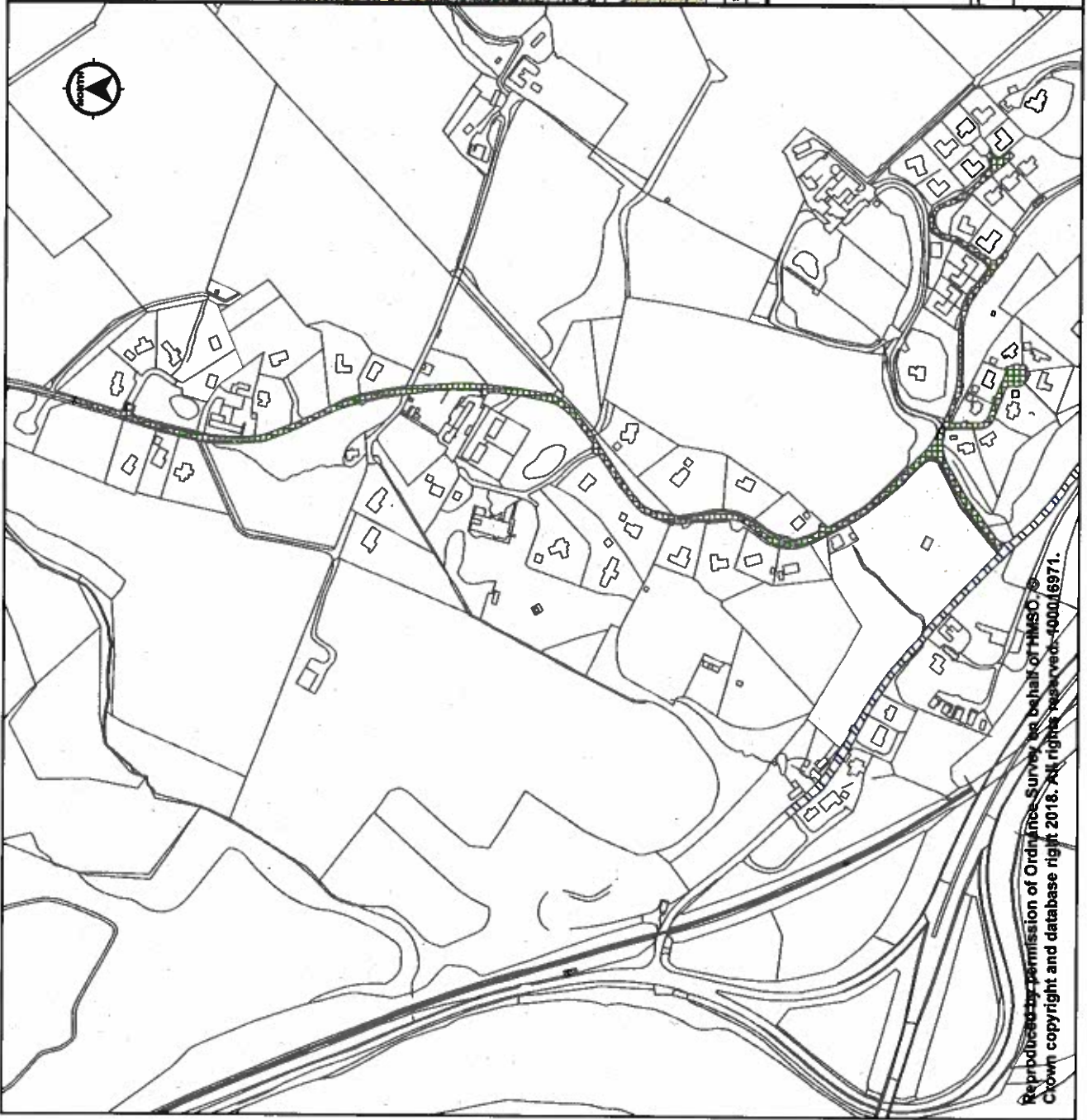
**"20A CROFTINLOAN**

**U165 – CROFTINLOAN – KINNAIRD ROAD**

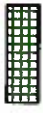
From its junction with the C503 East Haugh Road (old A9 road) northwards for a distance of 1 kilometre or thereby."

### **Council reasons**

The Council wish to introduce a 30mph speed limit on the U165 Croftinloan in an effort to reduce the risk of road accidents and to improve conditions for cyclists, pedestrians and all road users.
