**PERTH AND KINROSS COUNCIL (RESTRICTED ROADS)
(VARIATION) (NO 35) ORDER 2019
(20/19)**

Perth and Kinross Council in exercise of the powers conferred on them by Sections 84(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which Act of 1984 is hereinafter referred to as "the Act") and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as the "Perth and Kinross Council (Restricted Roads) (Variation) (No 35) Order 2019" and shall come into operation on the Twenty-second day of June Two thousand and nineteen.
2. The Perth and Kinross Council (Restricted Roads) Order 1998 is hereby varied and shall henceforth have effect subject to the amendments thereto specified and described in the Schedule hereto.

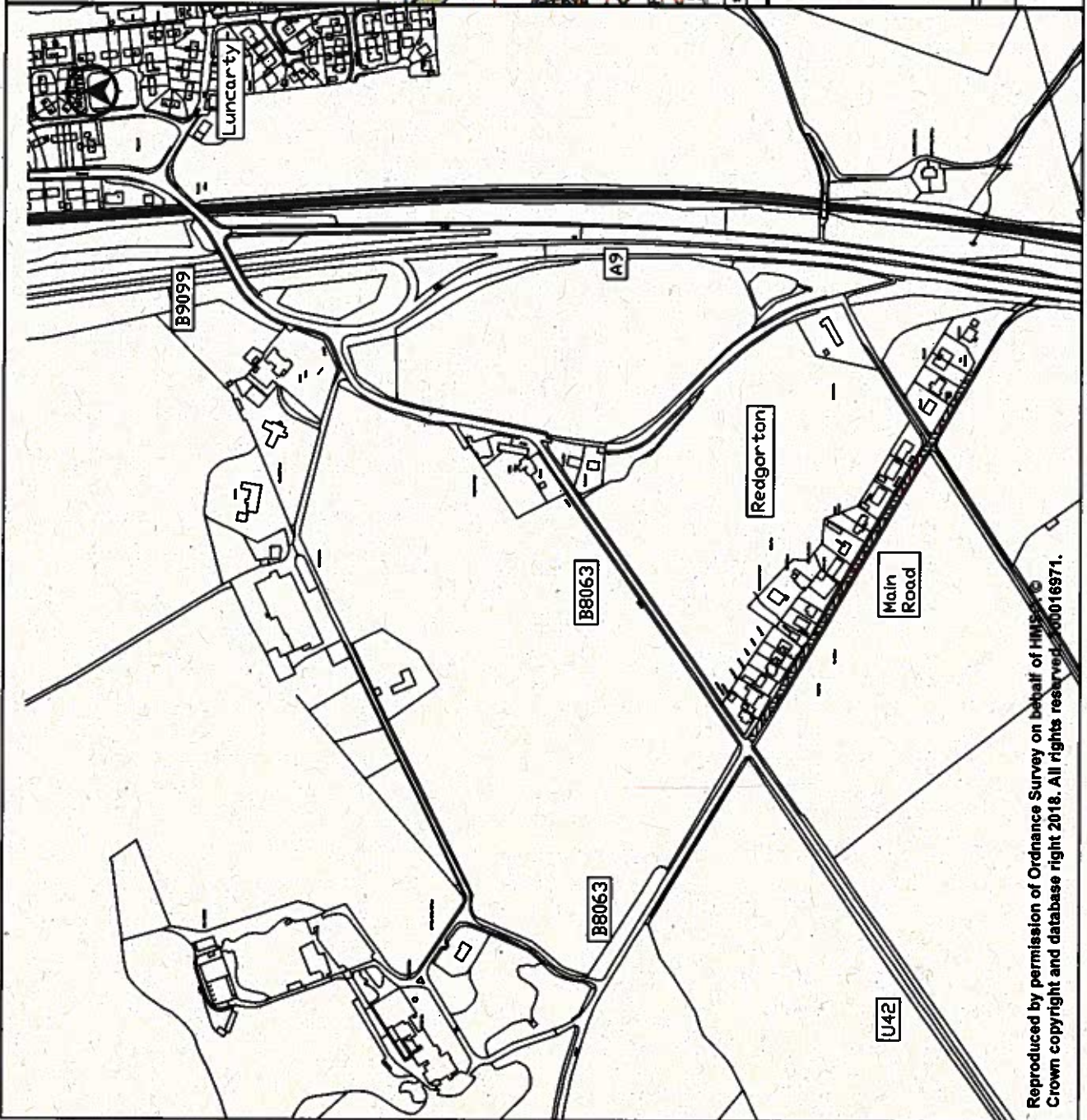
SCHEDULE

The Schedule to the "Perth and Kinross Council (Restricted Roads) Order 1998" requires to be varied as follows:-

1. At **PART 1** of the **SCHEDULE, 44 PERTH** at section (h) **B9112** in line 2 after the words "for a distance of" delete "510 metres" and substitute with "605 metres".
2. At **PART 1** of the **SCHEDULE**, after **46 POWMILL** insert:-
"46A REDGORTON
Main Street
From its junction with the Luncarty - Moneydie Road (B8063) southeastwards for a distance of 428 metres or thereby."
3. Renumber the existing **46A RUMBLING BRIDGE** as **46B RUMBLING BRIDGE**.

Council reasons

The Council wish to introduce a 30mph speed limit on Main Street, Redgorton in an effort to reduce the risk of road accidents and to improve conditions for cyclists, pedestrians and all road users.
