South Ayrshire Council in exercise of the powers conferred on it by Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended and all other enabling powers, and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order—

PART I GENERAL

Citation and commencement

1. This Order may be cited as "South Ayrshire Council (Various Roads, Crosshill) (20mph & 30mph Speed Limit) (Amendments & Revocations) Order 2022" and shall come into force on the 5th day of May 2022.

Interpretation

- 2. In this Order the following expressions have the meanings hereby assigned to them—
 - "Motor vehicle" unless the context otherwise requires, means a motor vehicle to include a mechanically propelled intended or adapted for use on the road;
 - "Schedule" means the Schedule's 1 to 3 annexed to this Order and which form part of this Order;
 - "The 1984 Act" means The Road Traffic Act 1984;
 - 3. A reference in this Order to
 - (a) Any enactment or order is a reference to that enactment or order as amended by any subsequent enactment or order;
 - (b) A numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order; and
 - (c) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to an Act of Parliament.

PART II SPEED LIMITS

Speed Limits

- 4. Save as provided in Article 6 it shall not be lawful for any person to drive a motor vehicle at a speed exceeding 20 mph on the lengths of the roads specified in Schedule 1.
- 5. Save as provided in Article 6 it shall not be lawful for any person to drive a motor vehicle at a speed exceeding 30 mph on the lengths of the roads specified in Schedule 2.
- 6. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.

PART III REVOCATIONS

Orders to be revoked

7. The Orders or parts thereof specified in Schedule 3 are hereby revoked.


