South Ayrshire Council (Ballantrae and Troon) (Temporary Off-Street Parking Places for Motor Caravans) Order 2024

South Ayrshire Council in exercise of the powers conferred on it under Section 14(1) of the Road Traffic Regulation Act 1984, as amended, the Road Traffic (Permitted Parking Area and Special Parking Area) (South Ayrshire Council) Designation Order 2012 and the Road Traffic Act 1991 and of all other enabling powers, hereby makes the following Order:

Part I

GENERAL

Citation and commencement

1. This Order may be cited as "South Ayrshire Council (Ballantrae and Troon) (Temporary Off-Street Parking Places for Motor Caravans) Order 2024" and shall come into force at 00:01 hours on Monday 1 April 2024 and will remain in force until 23:59 hours on Tuesday 30 September 2025.

Interpretation

2. In this Order the following expressions have the meanings hereby assigned to them:

"Schedule" means the Schedule(s) annexed as relative hereto;

"vehicle" includes any motor car, motor cycle or other mechanically propelled automobile.

"Council" means South Ayrshire Council.

3. A reference in this Order to any enactment is a reference to that enactment as amended by any subsequent enactment.

4. A reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

PART II

AMENDMENTS

5. The 2013 Order specified in the Schedule shall have effect subject to the amendments specified in the Schedule annexed as relative hereto.

Title of Order

6. South Ayrshire Council (Off-Street Parking Places) (Charging, Controlling and Decriminalised Enforcement) Order 2013.

Extent of Amendments

Interpretation

7. Article 2, substitute the wording ""daily charge" means the charge imposed by the Council for parking in a parking place on any one day and for a specified period of time as is identified in the scale of charges specified in as advertised in the parking place;" to read;

""daily charge" means the charge imposed by the Council for parking in a parking place on any one day, overnight where permitted, and for a specified period of time as is identified in the scale of charges specified in or as advertised in the parking place;"

8. Article 2, insert:

""motor caravan" as defined by the Road Vehicles (Construction and Use) (Amendment) (No2) Regulations 1987 means a motor vehicle which is constructed or adapted for the carriage of passengers and their effects and which contains, as permanently installed equipment, the facilities which are

reasonably necessary for enabling the vehicle to provide mobile living accommodation for its users."

Extent of Amendments

Part 2. Designation and Use of Parking Places.

9. After Article 16 insert new Article 16A:

Motor Caravan parking bays

16A. No person shall cause or permit a vehicle to park in a parking bay marked for motor caravans unless the vehicle is a motor caravan -

- (a) For a longer period than 15 hours during the charging hours; or
- (b) If a period of less than twenty-four hours has elapsed since the expiry of a maximum duration stay by that vehicle in any of the parking bays for motor caravans.

Extent of Amendments

Part 4. Exemptions.

- 10. Article 42, substitute the wording "(i) a vehicle which displays in the relevant position a valid disabled person's badge provided that the vehicle immediately before or after the act of parking has been used or is about to be used by the person(s) in respect of whom the badge is issued;" to read;
 - "(i) a vehicle which displays in the relevant position a valid disabled person's badge provided that the vehicle immediately before or after the act of parking has been used or is about to be used by the person(s) in respect of whom the badge is issued unless parked in a parking bay for motor caravans when the daily charge shall apply;

Extent of Amendments

Part 7. Liability and other Provisions.

- 11. Article 58 substitute the wording "Any person who uses any part of the parking place or any vehicle parked in a parking place
 - (i) For sleeping or camping or cooking, or
 - (ii) For the purpose of servicing or washing any vehicle or part thereof other than is reasonably necessary to enable the vehicle to depart from the parking place, shall be liable to prosecution." to read;

"Any person who uses any part of the parking place or any vehicle parked in a parking place

- (i) For sleeping or camping or cooking, washing crockery, cutlery, clothing or any other articles whatsoever, or
- (ii) For the purpose of servicing or washing any vehicle or part thereof other than is reasonably necessary to enable the vehicle to depart from the parking place, shall be liable to prosecution."

Extent of Amendments

Part 7. Liability and other Provisions.

12. Article 59 substitute the wording "Nothing in Articles 58 or 60 shall prevent the driver of a bus, coach or large goods vehicle from cooking, resting or sleeping in their vehicle for up to 8 hours when parked in a parking place designated for bus, coach or large goods vehicles." to read;

"Nothing in Articles 58 or 60 shall prevent the driver of a bus, coach, large goods vehicle or motor caravan from cooking, resting or sleeping in their vehicle for up to 15 hours when parked in a parking place designated for bus, coach, large goods vehicle or motor caravan."

- 13. Article 60 substitute the wording "(vi) No person shall wilfully sound any horn or any other similar instrument on a vehicle except when about to change the position of the vehicle in or to depart from the parking place." to read;
 - "(vi) No person shall wilfully sound any horn on a vehicle or use any auxiliary motor or generator except when about to change the position of the vehicle in or to depart from the parking place, or wantonly shout, operate a radio, loudspeaker or any other similar instrument or otherwise make any loud noise to the disturbance or annoyance of users of the parking place or residents or occupiers of premises in the neighbourhood."
- 14. Article 60 substitute the wording "(viii) No person, except drivers of bus, coach and large goods vehicles shall use a vehicle or trailer as sleeping accommodation while it is parked within a parking place between the hours of 11.00pm and 7.00am." to read;
 - "(viii) No person, except drivers of a bus, coach, large goods vehicle or motor caravan shall use a vehicle or trailer as sleeping accommodation while it is parked within a parking place between the hours of 6.00pm and 9.00am."
- 15. Article 60 substitute the wording "(xi) No person shall erect or cause to be erected in a parking place any tent; booth, stand, building or other structure without written permission of a person duly authorised by the Council to give such permission.." to read;
 - "(xi) No person shall erect or cause to be erected in a parking place any line, cable, tent, booth, stand, building or other structure without written permission of a person duly authorised by the Council to give such permission."
- 16. After Article 60 (xiv) insert new paragraph (xv):
 - (xv) No person shall drive any motor vehicle around such parking place unnecessarily, recklessly, erratically, dangerously, or play any game or sport involving motor vehicles, motor sport or motor trials.

Extent of Amendments
