The Stirling Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order:-

- This Order may be cited as "The Stirling Council (A84 Millenium Way, Stirling) (Temporary Footway Closure and Suspension of Parking – Extension) Order 2021" and shall come into operation on the Twenty-Eighth day April Two Thousand and Twenty-One.
- The effect of this Order shall be to close to pedestrians from 0800 hours until 1700 hours from 28 April 2021 until 3 May 2021 the sections of footway as detailed in Schedule 1 hereto to facilitate footway and drainage works.
- 3. The effect of this Order shall be suspend the parking from hours from 0800 hours until 1700 hours from 28 April 2021 until 3 May 2021 on the sections of road as detailed in Schedule 2 hereto to facilitate footway and drainage works.


Statement of Reasons for Making the Order
